To acquire by purchase, lease or otherwise and to own, operate and maintain a business for the purpose of an electrical contractor including, without limitation, to design, devise, invent, manufacture, install, remove, repair, inspect, report upon, buy, sell, handle, and deal in machinery, plants, apparatus, appliances, accessories, equipment, supplies, and means and materials, of all kinds, for the generation, production, transmission, transformation, accumulation, storage, distribution, supplying, application and utilization of electricity for all purposes. In addition, to solicit, bid for, enter into, and perform contracts for the doing of electrical work and furnishing of electrical machinery, appliances, accessories, materials and supplies of all kinds. To provide property management and maintenance services, carpentry and construction projects for new and/or renovation purposes. To do all of the foregoing and any and all activities necessary or desirable in connection with any of the foregoing, or in any way ancillary or related thereto and all other lawful business for which a corporation may be formed under the General Laws of the State of Rhode Island (excepting banking and insurance).
