ORIGINAL ARTICLES OF ASSOCIATION

(BUSINESS CORPORATION)

Know all Men by these Fresents. That we ANTHONY J. BUCCI, GLORIA COLELLA and CHARLES A. CURRAN
all of lawful age, hereby agree to and with each other: FIRST. To associate ourselves together with the intention of forming a corporation under and by virtue of the powers conferred by Chapters 7-1 to 7-5 (inclusive), 7-9 and 7-10 of the General Laws of Rhode Island, as amended. SECOND. Said corporation shall be known by the name of
HARMONY PATTERN & CASTING CO., INC.
THIRD. Said corporation is formed (as permitted by § 7-2-8 of the General Laws) for the purpose of manufacturing of wood and metal patterns and non-ferrous
castings and any and all other things necessary and incidental thereto
In addition to the foregoing, said corporation shall have the following powers and authority, viz:—(See § 7-2-10 of the General Laws.)
To do any lawful act which is necessary or proper to accompliab the purposes of its incorporation. Without limiting or onlarging the effect of this general grant of authority, it is hereby specifically provided that every corporation shall have power:
(a) to have perpetual succession in its corporate name, unless a period for its duration is limited in its articles of association or charter;
(b) to sue and be sued in its corporate name;(c) to have and use a common seal, and alter the same at pleasure;
(d) to elect such officers and appoint such agents as its business requires, and to fix their compensation and define their duties;
(e) to make by-laws not inconsistent with the Constitution or laws of the United States or of this state, or with the corporation's charter, or articles of association, determining the time and place of holding and the manner of calling and of conducting meetings of its stockholders and directors, the manner of electing its officers and directors, the mode of voting by proxy, the number, qualifications, powers, duties and term of office of its officers and directors, the number of directors and of shares of stock necessary to constitute a quorum, which number may be less than a majority, and the method of making demand for payment of subscriptions to its capital stock, and providing for an executive committee to be elected from and by the board of directors and defining its powers and duties, and containing any other provisions, whether of the same or of a different nature, for the management of the corporation's property and the regulation and government of its affairs; (f) to make contracts, incur liabilities and borrow money;
(a) to sconice hold, sell and transfer shares of its own capital stock; provided, that no corporation shall use
its funds or proporty for the purchase of its own shares of capital stock when such use would cause any impairment of the capital of the carporation;
