ORIGINAL ARTICLES OF INCORPORATION

The undersigned, acting as incorporator(s) of a corporation under Chapter 7-6 of the General Laws, 1956, as amended, adopt(s) the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is NARRAGANSETT ASSOCIATION OF CLERICAL TECHNICAL PERSONNEL

SECOND: The period of its duration (if perpetual, so state) PERPETUAL

THIRD: The purpose or purposes for which the corporation is organized are: To develop and improve working conditions for Narragansett Association of Clerical/Technical Personnel. To promote self-improvement for members and to create goodwill between NACTP personnel and members of the community.

To represent members in collective bargaining relationships with employer, grievance processing and other employment related matters, advise members of developments relating to or having an impact upon the performance and practice of their profession, and any other lawful business.
