"EXHIBIT A"

ORGANIZATIONAL PURPOSE

The limited liability company is being formed for the following purposes:

To perform residential and commercial contracting, including but not limited to carpentry, remodeling, refurbishing, restoring, tiling, plastering, siding, painting, installation of doors and replacement windows, decking, patios, porches and acting as a General Contractor.

To hire and employ agents, servants, and employees, and to enter into agreements of employment and collective bargaining agreements, and to act as agent, contractor, trustee, factor, or otherwise, either alone or in company with others.

To promote or aid in any manner, financially or otherwise, any person, firm association, or limited liability company, and to guarantee contracts and other obligations.

To let concessions to others to do any of the things that this limited liability company is empowered to do, and to enter into, make, perform, and carry out, contracts and arrangements of every kind and character with any person, firm, association, or limited liability company, or any government, local or foreign, or authority or subdivision or agency thereof.

To carry on any business whatsoever that this Limited liability company may deem proper or convenient in connection with any of the foregoing purposes or otherwise, or that it may deem calculated, directly or indirectly, to improve the interests of this limited liability company, and do all things specified by State and national law, and to have and to exercise all powers conferred by the laws of the State of Rhode Island on limited liability companies formed under the laws pursuant to which and under this limited liability company is formed, as such laws are now in effect or may at any time hereafter be amended, and to do any and all things hereinabove set forth to the same extent and as fully as natural persons might or could do, either alone or in connection with other persons, firms, associations, or limited liability companies, and in any part of the world.

The foregoing statement of purposes shall be construed as a statement of both purposes and powers, shall be liberally construed in aid of the powers of this limited liability company, and the powers and purposes stated in each clause shall, except where otherwise stated, be in no way limited or restricted by any term or provision of any clause, and shall be regarded not only as independent purposes, but the purposes and powers stated shall be construed distributively as each object expressed, and the enumeration as to specific powers shall not be construed as to limit in any manner the aforesaid general powers, but are in furtherance of, and in addition to and not in limitation of said general powers.

In general to have and exercise any and all powers that limited liability companies have and may exercise under the laws of the State of Rhode Island and as the same may be amended, except such powers as are inconsistent with the express provisions of these Articles of

Organization.
