ORIGINAL ARTICLES OF INCORPORATION

The undersigned acting as Incorporator(s) of a corporation under Chapter 7-1.1 of the General Laws, 1956, as amended, adopt(s) the following Articles of Incorporation for such corporation:

1. The name of the corporation is M/C Renovations, Inc.

(This is a close corporation pursuant to § 7-1.1-51 of the General Laws, 1956, as amended) (strike if inapplicable)

2. The period of its duration is (if perpetual, so state) Perpetual.

3. The specific purpose or purposes for which the corporation is organized are:

(1) General contracting, building construction, renovation and related services; and

(2) To transact any and all business for which corporations may be incorporated under the Rhode Island Business Corporations Act.

Notwithstanding the provisions of Section 7-1.1-24 of the General Laws, 1956, as amended, all shareholders shall have those preemptive rights specifically set forth in the By-Laws of the Corporation.


