AMENDMENT TO AMENDED AND RESTATED AGREEMENT OF LIMITED PARTNERSHIP

This AMENDMENT TO AMENDED AND RESTATED AGREEMENT OF LIMITED PARTNERSHIP (the "Amendment") is entered into as of November $\frac{S}{S}$, 2006 by and between Vincent J. Mesolella, Jr. (the "General Partner") and Preservation of Affordable Housing, Inc., an Illinois corporation, as limited partner ("Limited Partner") with respect to that certain Amended and Restated Agreement of Limited Partnership of Hillside Associates, l.p. (the "Partnership") dated as of January 15, 1991 by and among the General Partner and Vincent Mesolella ("Withdrawing General Partner"), as the original general partners, and Rhode Island Housing Equity Pool, L.P., as the original limited partner (the "Withdrawing Limited Partner")(the "Agreement"). WHEREAS, upon such involuntary withdrawal, the Interest of the Withdrawing General Partner inured to the benefit of the General Partner as his heir per Section 11.02 of the Agreement;

WHEREAS, the Withdrawing Limited Partner has donated as a charitable donation its limited partner interest in the Partnership to the Limited Partner pursuant to that Assignment and Assumption Agreement of even date hereof;

WHEREAS, the parties desire to amend the Agreement pursuant to Section 11.07 in order to reflect such changes to the Partnership and to continue the business of the Partnership.

NOW THEREFORE, the General Partner and the Limited Partner hereby agree to amend the Agreement as follows, effective as of the date first written above:

1. That Schedule I of the Agreement be deleted in its entirety and replaced with the following:
