**ARTICLE I**

The name of the corporation is Big Family Fun, Incorporated

The specific purpose or purposes for which the corporation is organized are:

THIS CORPORATION IS A NONPROFIT PUBLIC BENEFIT ORGANIZATION AND IS NOT ORGANIZED FOR THE PRIVATE GAIN OF ANY PERSON. Provisions, if any, not inconsistent with the law, which the incorporators elect to set forth in these articles of incorporation for the regulation of the internal affairs of the corporation are:

THIS ORGANIZATION WILL BE FUNDED BY GRANTS, INDIVIDUAL CONTRIBUTIONS/DONATIONS, AND FEES FOR SERVICES ON A SLIDING SCALE BASED ON INCOME. THE CORPORATION IS LIABLE FOR DEBTS. DIRECTORS/EMPLOYEES ARE NOT PERSONALLY LIABLE FOR THE DEBT OF THE CORPORATION. PROFITS CANNOT BE DISTRIBUTED AMONG MEMBERS OR OFFICERS. PROFITS CAN ONLY BE USED TO PURSUE THE STATED PURPOSES OF THIS ORGANIZATION.
