ORIGINAL ARTICLES OF INCORPORATION

The undersigned acting as incorporator(s) of a corporation under Chapter 7-1.1 of the General Laws, 1956, as amended, adopt(s) the following Articles of Incorporation for such corporation:

FIRST The name of the corporation is AHARONIAN & ASSOCIATES, INC.

(A close corporation pursuant to §7-1.1-51 of the General Laws, 1956, as amended) (strike if inapplicable)

SECOND The period of its duration is (if perpetual, so state) perpetual

THIRD The purpose or purposes for which the corporation is organized are:

To provide professional architectural services, which include the designing and planning of buildings and the supervising of their construction, and the doing and performing of any and all acts and things necessary, proper or convenient for or incidental to the furtherance or the carrying out of the powers or purposes herein mentioned.


