





**CONSTITUTION AND BY-LAWS**  
**BLACKSTONE VALLEY BAPTIST CHURCH**

**ARTICLE I. - NAME**

This organization shall be known as The BLACKSTONE VALLEY BAPTIST CHURCH, of Cumberland, Rhode Island.

C. BAPTISM: Persons may be received into membership upon giving a public confession of faith in Jesus Christ as his or her personal Saviour and following Him through the baptismal waters.


