

#### CONSTITUTION AND BY-LAWS

#### BLACKSTONE VALLEY BAPTIST CHURCH

#### ARTICLE L - NAME

This organization shall be known as The BLACKSTONE VALLEY BAPTIST CHURCH, of Cumberland, Rhode Island.

#### ARTICLE IL - METHODS OF OPERATION

The means employed in carrying out the afore mentioned Church Covenant (Inst. No. I) shall be:

- A. Personal Evangelism
- B. Regular Worship Services
- C. Prayer Meetings
- D. Distribution of Literature
- E. Support of Missionaries
- F. Maintenance of, and/or support of christian schools

#### ARTICLE IIL - AUTHORITY

The Holy Scriptures shall be accepted as final authority on all matters relating to faith and practice by the members of this church.

A. The authorized King James Translation of 1611 (A.V.) shall be the only textbook used in any of the worship services and Bible studies of this church.

- A. LETTER: Persons may be received into membership upon the reception of a letter of transfer from some other Baptist Church.
- B. STATEMENT: Persons may be received into membership upon giving a public statement of salvation, having been previously baptized by immersion into a Baptist church.
- C. BAPTISM: Persons may be received into membership upon giving a public confession of faith in Jesus Christ as his or her personal Saviour and following Him through the baptismal waters. the second of the second
