HEREBY CERTIFY, that at a meeting of the stockholders of said corporation, duly called
for the purpose, and held in the Town of Little Compton,
in said State, on the 9th day of February, A. D. 19 82,
the following amendment(s) to the Articles of Association (~~or Charter~~) was (~~or were~~)
duly adopted by an affirmative vote of the following proportion of the stockholders of
said corporation, viz:—

which said vote amends or adds the following Article(or Articles)to read as follows,viz.—

“Article No. THIRD: Said corporation is constituted for the purpose
of promoting and encouraging social, literary, artistic and civic interests,
activities and undertakings by and among its members, in the Town of Little
Compton, and by and among all residents and inhabitants of said Little
Compton, for the welfare and prosperity of the community.
The Little Compton Village Improvement Society is organized for non-profit
purposes and no part of the income of the corporation shall inure to the
benefit of any member, director or officer of the corporation or any private
individual therein. No substantial part of the activities of the corpora-
tion shall be the carrying on of propaganda and the corporation shall not
participate in or intervene in any political campaign on behalf of any
candidate for public office. Notwithstanding any other provision of
these Articles, the corporation shall not carry on any other activities
not permitted to be carried on, (a) by a corporation exempt from Federal
Income Tax under Section 501 (c) (3) of the Internal Revenue Code or (b)
by a corporation, contributions to which are deductible under a Sec-
tion 170 (c) (2) of the Internal Revenue Code.
