If the information is inconsistent with the records of this office, the statement will be returned.
- It is required by law to provide a street address in item 3 of the preceding form in order to provide the public with notice of a physical location at which process, notice or demand required or permitted by law may be served on the registered agent. A statement submitted with a post office box address only will not be accepted for filing.
- The statement must be signed on behalf of the corporation by its president or a vice president.
- 4. The change of address of the registered office or the appointment of a new registered agent, or both, as the case may be, shall become effective upon the date of filing with the Secretary of State.
- The fee for filing the Statement of Change of Registered Office or Registered Agent is \$10.00, and payment should be made payable to the Rhode Island Secretary of State.
