- The effective date of the statement shall be the date of filing with the Secretary of State or upon such later date not more than thirty (30) days after such filing, as may be set forth in item 6 of the statement.
- The statement must be signed on behalf of the corporation by its president or vice president. The president's or vice president's signature must be notarized.
