Except for those actions excluded by Section 7-16-21 (b)(1)(2) and (3) of the Rhode Island Limited Liability Company Act, any action required or permitted to be taken at a meeting of the members may be taken without a meeting upon the written consent of less than all the members entitled to vote thereon if the members who so consent would be entitled to cast at the least the minimum number of votes which would be required to take such action at a meeting at which all members entitled to vote thereon were present. In the event of such written action, prompt notice of such action shall be given to all members who would have been entitled to vote upon the action if such meeting were held.
- 2.
