Exhibit "A" To the Articles of Incorporation Of A-1 Corporate CPR, Inc.

SIXTH: FOR THE REGULATION OF THE BUSINESS AND THE CONDUCT OF THE INTERNAL AFFAIRS OF THE CORPORATION, IT IS FURTHER PROVIDED:

STOCK OF THIS CORPORATION MAY BE ISSUED FROM TIME TO TIME FOR SUCH CONSIDERATION CONSISTING OF CASH, PERSONAL PROPERTY, TANGIBLE AND INTANGIBLE, OR REAL ESTATE OR SUCH OTHER CONSIDERATION THAT SHALL BE DETERMINED FROM TIME TO TIME BY THE STOCKHOLDERS OF THIS CORPORATION. NO STOCKHOLDER OF THIS CORPORATION SHALL MAKE SALE OF ANY STOCK OF SAID CORPORATION HELD BY HIM, WITHOUT FIRST GIVING WRITTEN NOTICE TO THE CORPORATION OF HIS INTENTION TO SELL THE SAME AND GIVING TO THE CORPORATION, THE RIGHT TO PURCHASE SAID STOCK AT THE LOWEST PRICE AT WHICH HE IS WILLING TO SELL BEFORE THE SAME SHALL BE SOLD BY HIM TO ANY OTHER PARTY. THE CORPORATION SHALL EXERCISE THE RIGHT TO PURCHASE THE STOCK SO OFFERED TO IT WITHIN 30 DAYS OF THE RECEIPT OF SAID OFFER. IF NOT ACCEPTED WITHIN SAID DATE, THE STOCKHOLDER SHALL BE AT LIBERTY TO MAKE SALE OF SAID STOCK SO OFFERED TO THE CORPORATION IN THE OPEN MARKET FOR A PRICE OF NOT LESS THAN A PRICE AT WHICH SAID STOCK IS OFFERED TO THE CORPORATION.
