(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is The Suge White Foundation

The specific purpose or purposes for which the corporation is organized are:

THE PURPOSE FOR WHICH THIS CORPORATION IS ORGANIZED IS TO ENGAGE IN ANY SUCH LAWFUL ACT AND/OR ACTIVITY UNDER THE GENERAL LAW OF RHODE ISLAND OTHER THAN THE BANKING BUSINESS, TRUST COMPANY BUSINESS OR THE PRACTICE OF A PROFESSION NOT PERMITTED TO BE INCORPORATED BY AND PURSUANT TO THE RHODE ISLAND CORPORATIONS STATUTE BUT MORE SPECIFICALLY, COMMUNITY SUPPORTS AND MORE SPECIFICALLY THAN THAT, HELPING THE HOMELESS AND CHILDREN.
