ORIGINAL ARTICLES OF INCORPORATION

The undersigned, acting as incorporator(s) of a corporation under Chapter 7-6 of the General Laws, 1956, as amended, adopt(s) the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is NORTH PROVIDENCE FIREFIGHTERS ATHLETIC ASSOCIATION, INC.

SECOND: The period of its duration (if perpetual, so state) perpetual

THIRD: The purpose or purposes for which the corporation is organized are:  
To provide athletic teams, athletic programs, and athletic activities for the members of the North Providence Fire Department, to promote good physical condition and health for its members, and to provide athletic scholarships for college for the children in the Town of North Providence who are in need of financial aid, and any other lawful purpose allowed by the General Laws of the State of Rhode Island.


