TENTH. Each or any limited partner shall have the right to substitute an assignee as contributor in his place, subject to the following terms and conditions: only:

(i) with the prior consent of the general partner, which consent shall not be unreasonably withheld, and (ii) after such assignee shall have executed such instruments as shall be required by the general partner to signify said assignee's agreement to be bound by all of the provisions of the limited partnership agreement.

ELEVENTH. The partners shall have the right to admit additional limited partners.

TWELFTH. No ~~xa~~ limited partner, shall have the right to priority over the other limited partners as to contributions or as to compensation by way of income. ~~and the nature of such priority shall be~~

insolvency or dissolution of the
THIRTEENTH. Upon the ~~death, retirement or incapacity of~~ a general partner, the remaining general partner or partners shall have the right to continue the business.

FOURTEENTH. Any limited partner shall not have the right to demand and receive property other than cash in return for his contribution.
