which said vote amends or adds the following Article(or Articles) to read as follows, viz.—

"Article No. FIFTH. " The total number of shares of capital stock
authorized without par value shall be One Thousand (1,000) shares
as follows: viz: One Thousand (1,000) shares of Common stock
without par value. "

Paragraph 1 thereof shall be amended to read as follows:

"The total authorized capital stock of this corporation shall
be divided into Three Thousand (3,000) Shares of which Two
Thousand (2,000) shares shall be preferred stock and shall be
issued at a par value of One Hundred (\$100.) Dollars each and
One Thousand (1,000) shares shall be common stock without par
value."

Paragraph 3 thereof shall be amended to read as follows:

"The preferred capital stock shall have no voting power whatever
at any time. Five Hundred (500) shares of common capital stock

shall be surrendered and in its place shall be issued One
Thousand (1,000) shares of common stock which shall be divided
into two classes, to wit:

CLASS A -- Two Hundred (200) shares of voting Common stock.
No par value.

CLASS B -- Eight Hundred (800) shares of non-voting Common
stock. No par value."
