## CERTIFICATE AND AGREEMENT OF LIMITED PARTNERSHIP

AGREEMENT OF LIMITED PARTNERSHIP, made as of the 19th day of December, 1991 by and between PAWTUCKET NEIGHBORHOOD APARTMENTS, INC., a Rhode Island corporation ("PNA"), of Providence, Rhode Island, as the General Partner, and WOMEN'S OPPORTUNITY REALTY CORPORATION, a Rhode Island non-profit corporation ("WORC"), of Providence, Rhode Island, as the Limited Partner (sometimes both referred to collectively as the "partners"):

## WITNESSETH:

- 1. <u>Formation</u>. The parties hereto do hereby form a limited partnership pursuant to the provisions of Chapter 13 of Title 7 of the General Laws of Rhode Island.
- 2. <u>Name</u>. The business of the partnership shall be conducted under the name of Neighborhood Preservation Apartments L.P.
- 3. Term. The term of the partnership commences on the date herein written above and continues until December 31, 2050, unless dissolution otherwise occurs prior to that date.
- 4. <u>Purpose</u>. The purpose of this limited partnership is to purchase, own, develop, hold and sell real estate and to engage in a general real estate business.
- 5. Principal Office and Agent for Service of Process. The principal place of business of this limited partnership shall be at 861A Broad Street, Providence, Rhode Island 02907 or any other place as the partners may from time to time determine. Susan Aitcheson with an address of 861A Broad Street, Providence, Rhode Island, is hereby appointed and designated as the agent for service of process for this limited partnership.
- 6. <u>Partners</u>. The following are the partners of this limited partnership:

- 7. <u>Capital Contributions by the Partners</u>. The partners agree to make contributions to capital in such amounts and at such times as are deemed necessary by mutual agreement of the partners for the operation of the partnership business.
- 8. <u>Income and Losses</u>. All net income of the partnership shall be credited to the capital accounts of the partners in the proportions set opposite their respective names below:
