Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

**ARTICLE I**

The name of the corporation is Friends of South Kingstown Schools

**ARTICLE II**

The period of its duration is  Perpetual  \_\_\_\_\_

**ARTICLE III**

The specific purpose or purposes for which the corporation is organized are:

FRIENDS OF SOUTH KINGSTOWN SCHOOLS IS ORGANIZED EXCLUSIVELY TO PURSUE EDUCATIONAL ACTIVITIES, ADVOCACY, LOBBYING, AND LIMITED POLITICAL ACTIVITIES IN SUPPORT OF SOUTH KINGSTOWN SCHOOL DISTRICT'S PUBLIC SCHOOLS (PRE-K – 12) AND FUNDING OF THE PUBLIC EDUCATION SYSTEM IN SOUTH KINGSTOWN.

**ARTICLE IV**

Provisions, if any, not inconsistent with the law, which the incorporators elect to set forth in these articles of incorporation for the regulation of the internal affairs of the corporation are:

QUALIFICATIONS: DIRECTORS NEED NOT BE RESIDENTS OF SOUTH KINGSTOWN. NO PERSON SHALL SERVE AS A DIRECTOR OF THE CORPORATION IF HE OR SHE HAS A DIRECT OR INDIRECT PERSONAL OR FINANCIAL RELATIONSHIP WHICH WOULD MATERIALLY IMPAIR HIS OR HER ABILITY TO ACT SOLELY IN THE INTERESTS OF THE CORPORATION. WHENEVER A DIRECTOR HAS A DIRECT OR INDIRECT PERSONAL OR FINANCIAL INTEREST IN A PARTICULAR TRANSACTION OR OTHER DECISION TO COME BEFORE THE BOARD OF DIRECTORS, HE OR SHE SHALL DISCLOSE SUCH PERSONAL OR FINANCIAL INTEREST TO THE BOARD OF DIRECTORS, WHICH SHALL TAKE SUCH ACTION, INCLUDING DISQUALIFICATION, AS IT DETERMINES TO BE APPROPRIATE.
