
ARTICLES OF INCORPORATION
(To Be Filed in Duplicate Original)

The undersigned acting as incorporator(s) of a corporation under Chapter 7-1.1 of the General Laws, 1956, as amended, adopt(s) the following Articles of Incorporation for such corporation:

1. The name of the corporation is **LANDSCAPE CREATIONS OF RHODE ISLAND, INC.**
(This is a close corporation pursuant to § 7-1.1-51 of the General laws, 1956, as amended) (Strike if inapplicable.)
2. The period of its duration is **perpetual**.
3. The specific purpose or purposes for which the corporation is organized are:
To operate the business of a landscaping contractor, including masonry work related thereto,
and to engage in all other lawful acts or activities for which a corporation may be organized under
the Rhode Island Business Corporation Act, as amended.
4. The aggregate number of shares which the corporation shall have authority to issue is:

5. Provisions (if any) dealing with the preemptive right of shareholders pursuant to § 7-1.1-24 of the
General Laws, 1956, as amended:
The provisions of § 7-1.1-24 of the General Laws of Rhode Island, 1956, as amended, are
incorporated herein by reference and made a part hereof.
6. Provisions (if any) for the regulation of the internal affairs of the corporation:
All provisions relating to the regulation of the internal affairs of the corporation shall be contained
in the bylaws.

8. The number of directors constituting the initial board of directors of the corporation is **one (1)**
