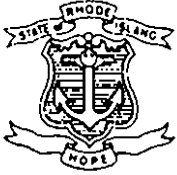

ORIGINAL ARTICLES OF INCORPORATION

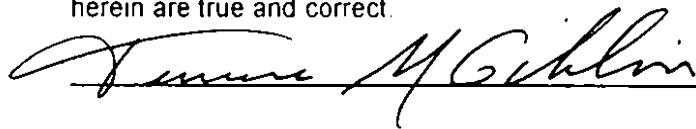
