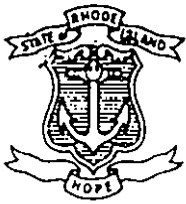

**ORIGINAL ARTICLES OF INCORPORATION**

The undersigned acting as incorporator(s) of a corporation under Chapter 7-1.1 of the General Laws, 1956, as amended, adopt(s) the following Articles of Incorporation for such corporation:

1. The name of the corporation is Providence Machine & Tool Works, Inc. *PM*

(This is a close corporation pursuant to § 7-1.1-51 of the General Laws, 1956, as amended) (strike if inapplicable)

3. The specific purpose or purposes for which the corporation is organized are:

Developing and manufacturing of metrology equipment, manufacturing of tooling and  
machinery for the electrical wire industry, doing industrial prototype and design,


