ARTICLES OF INCORPORATION

The undersigned acting as incorporator(s) of a corporation under Chapter 7-1.1 of the General Laws, 1956, as amended, adopt(s) the following Articles of Incorporation for such corporation:

1. The name of the corporation is IRON SIGHT APPLICATIONS, INC.

(This is a close corporation pursuant to § 7-1.1-51 of the General Laws, 1956, as amended.) (Strike if inapplicable)

2. The period of its duration is (if perpetual, so state) perpetual.

3. The specific purpose or purposes for which the corporation is organized are:

To own and operate a private security business, providing personal and financial security,

and to engage in all other lawful acts or activities for which a corporation may be

organized under the Rhode Island Business Corporation Act, as amended.

4. The aggregate number of shares which the corporation shall have authority to issue is:

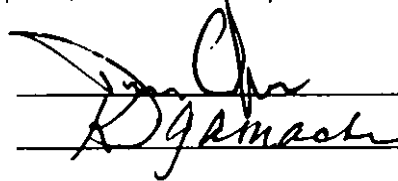

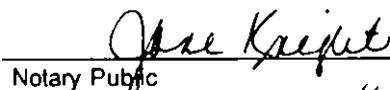
