The undersigned acting as incorporator(s) of a corporation under Chapter 7-1.1 of the General Laws, 1956, as amended, adopt(s) the following Articles of Incorporation for such corporation:

1. The name of the corporation is Coastal Rheumatology, P.C., Inc.

3. The specific purpose or purposes for which the corporation is organized are:

Rendering professional medical health care services and all lawful activities related thereto pursuant to all of the provisions of Chapter 5.1 of Title 7 of the General Laws of Rhode Island, 1956, as amended, the Professional Service Corporation Act, so-called, including the ownership and leasing of property, both real and personal, incident or ancillary to such professional services.

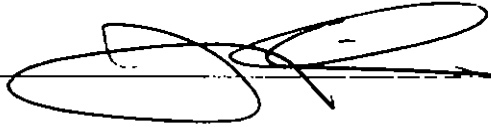
