

**ARTICLES OF INCORPORATION**  
(To Be Filed in Duplicate Original)

The undersigned acting as incorporator(s) of a corporation under Chapter 7-1.1 of the General Laws, 1956, as amended, adopt(s) the following Articles of Incorporation for such corporation:

1. The name of the corporation is **SNIPPERS HAIR SALON INC.**  
(This is a close corporation pursuant to § 7-1.1-51 of the General laws, 1956, as amended.) (Strike if inapplicable.)
2. The period of its duration is **perpetual**.
3. The specific purpose or purposes for which the corporation is organized are:  
To operate a hair salon and conduct the business of beautician, and to engage in all other lawful acts or activities for which a corporation may be organized under the Rhode Island Business Corporation Act, as amended.
4. The aggregate number of shares which the corporation shall have authority to issue is:  
  
(a) *If only one class:* Total number of shares **8000** with **\$1.00** par value.
5. Provisions (if any) dealing with the preemptive right of shareholders pursuant to § 7-1.1-24 of the General Laws, 1956, as amended:  
The provisions of § 7-1.1-24 of the General Laws of Rhode Island, 1956, as amended, are incorporated herein by reference and made a part hereof.
6. Provisions (if any) for the regulation of the internal affairs of the corporation:  
All provisions relating to the regulation of the internal affairs of the corporation shall be contained in the bylaws.
7. The address of the initial registered office of the corporation is **328 Cowesett Avenue, Suite #5, West Warwick, Rhode Island 02893** and the name of the initial registered agent at such address is **Bernard A. Poirier, C.P.A.**
8. The number of directors constituting the initial board of directors of the corporation is one and the names and addresses of the persons who are to serve as directors until the first annual meeting of shareholders or until their successors are elected and shall qualify are:


