Said notice shall be given by certified mail to the registered corporate agent for service of process. On its failure to exercise its option within thirty (30) days of the receipt of such notice, the holders of other voting common stock shall have fifteen (15) days thereafter to exercise their option to purchase said stock at said price. On the failure of such stockholders to exercise their option to purchase all of the stock offered for sale, the stockholder shall be free to sell the stock to any party for a price not less than that offered to the corporation.

All certificates of corporate stock shall contain the statement:

"Subject to restrictions on transfer as set forth in the Articles of Incorporation."
