ORIGINAL ARTICLES OF INCORPORATION

The undersigned, acting as incorporator(s) of a corporation under Chapter 7-6 of the General Laws, 1956, as amended, adopt(s) the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is.....View of Hope Association.....

SECOND: The period of its duration (if perpetual, so state).....perpetual.....

THIRD: The purpose or purposes for which the corporation is organized are:

holding land to be used for the exclusive benefit of all of the owners of the lots as they are now and as the owners shall change, from time to time, in that certain subdivision of real property situated in Tiverton, entitled "View of Hope" as shown on a plan dated February 6, 1984 and January 24, 1985, both of which are recorded in Plan Book 16, Page 94 and Plan Book 17, Page 9, respectively, of the Land Evidence Records of Tiverton, Rhode Island.

FOURTH: Provisions (if any) for the regulation of the internal affairs of the corporation, including provisions for the distribution of assets on dissolution or final liquidation, are: (Note 1)


If, as and when dissolution of the corporation were to occur, then any land owned by the corporation at such time, shall be transferred to the Town of Tiverton, Rhode Island, in fee simple.

If, at such time of dissolution, the corporation has possession of funds, contributed to it by the members, then any balance remaining after satisfaction of the corporation's debts and expenses, shall be distributed to the members, on a pro-rata basis, in conformity with their respective contributions thereto.


