AMENDMENT FOURTH TO THE
FIRST AMENDED AND RESTATED
AGREEMENT AND CERTIFICATE OF LIMITED PARTNERSHIP

Dated as of August 29th, 1986

Reference is made to the First Amended and Restated Agreement and Certificate of Limited Partnership of PSP Associates Limited Partnership, dated as of December 1, 1985 and filed with the Filing Office on December 31, 1985 (the "Partnership Agreement"), as amended by Amendment One to the First Amended and Restated Agreement and Certificate of Limited Partnership dated as of January 1, 1986 and filed with the Filing Office on January 14, 1986, Amendment Two to the First Amended and Restated Agreement and Certificate of Limited Partnership dated as of January 16, 1986 and filed in the Filing Office on January 31, 1986, and Amendment Three to the First Amended and Restated Agreement and Certificate of Limited Partnership dated as of February 28, 1986 and filed in the Filing Office on February 28, 1986.

Capitalized terms used herein, and not otherwise defined, shall have the respective meanings as set forth in the Partnership Agreement.

The purposes of this Amendment Four to the Partnership Agreement are (i) to admit the Investors listed in Exhibit A hereto (the "Investors") as additional Limited Partners, and (ii) to adjust the shares of profits, losses and residual interests allocated among the Partners.

NOW, THEREFORE, for and in consideration of the mutual promises of the parties hereto, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, it is hereby agreed as follows:

1. The General Partners hereby admit the Investors as additional Limited Partners pursuant to the provisions of Section 4.6A of the Partnership Agreement.

2. The Investors hereby agree to become Limited Partners and to be bound by all the provisions of the Partnership Agreement, as amended by this Amendment, the Project Documents and any other documents required in connection therewith to the same extent and on the same terms as the other Limited Partners.

3. Schedule A to the Partnership Agreement is hereby amended in its entirety to read as set forth in Schedule A attached hereto.

4. Except as expressly amended hereby, the Partnership Agreement as previously amended is hereby

ratified and confirmed and shall remain in full force and effect.
