
To whomever, it may concern,

- Vanny Nhem-Raphael, MBA was the Treasurer of the HPTA during the entire period. However, she is no longer the Treasurer or associated with HPTA (effective July 1, 2020). The address on record will change as a result.
  - Replacing Mrs. Raphael is the new treasurer for HPTA, Susan Tavares. She resides at 45 Public Street, East Providence, RI 02914.
- Kindly update your records to remove "130 Quarry Street, East Providence, RI 02914" (Mrs. Raphael's home address) from your records going forward, and replace it with "75 Fort Street, East Providence, RI 02914" as **the new principal address**.
