(NON-BUSINESS CORPORATION.)

Know all Men by these Presents, That we, Frank A. Faber, Walter Kania,
Joseph Sczempek, Kazimierz Korzen and Franciszek Bucko,

all of lawful age, hereby agree to and with each other:
First. To associate ourselves together with the intention of forming a corporation
under and by virtue of the powers conferred by Article III of Chapter 248 of the General
Laws of Rhode Island.
Second. Said corporation shall be known by the name of
The Church of the Holy Cross of Central Palls, R. I.
THIRD. Said corporation is constituted for the purpose of maintaining and conducting religious worship in accordance with the rites, practices and discipline of the Polish National Catholic Church of America, and in communion and affiliation therewith. Said corporation at all times shall be governed and regulated in all matters spiritual and temporal by the provisions of the constitution and by-laws of said National Church passed or enacted in pursuance thereof; provided, however, such provisions, rules and regulations shall be consistent and in conformity with the laws of the State of Rhode Island; and provided, further, said corporation shall also have the right to pass or enact such further by-laws as shall not be inconsistent with the constitution by-laws, rules and regulations of said National Church.
In addition to the foregoing, said corporation shall have the following powers and
authority, viz: - (See Sec. 75, Chapter 248 of the General Laws.)
To do any lawful act which is necessary or proper to accomplish the purposes of its incorporation. Without limiting or enlarging the effect of this general grant of authority, it is hereby specifically provided that said corporation shall have power: (a) to have perpetual succession in its corporate name, unless a period for its duration is limited in these articles of association:

(c) to have and use a common seal, and after the same at pleasure;

⁽b) to sue and be sued in its corporate name;

⁽d) to elect such officers and appoint such agents as its purposes require, and to fix their compensation and define their

⁽d) to elect such officers and appears that the constitution or laws of the United States or of this state, or with these articles of association, determining the time and place of holding and the manner of calling and of conducting meetings of its members and directors, the moner of electing its officers and directors, the mode of voting by proxy, and the number, qualifications, powers, duttes and term of office of its officers and directors, and containing any other provisions, whether of the same or of a different nature, for the management of the corporation's property and the regulation and government of its affairs;


