AND PEDESTRIAN INFRASTRUCTURE TO HELP MAKE STREETS SAFER PLACES TO EXERCISE, COMMUTE, EXPLORE, AND CONNECT. THROUGH GRASSROOTS ENGAGEMENT, COMMUNITY EDUCATION, AND THE SHARING OF EVIDENCE-BASED RESEARCH AND PUBLIC POLICY, SAFE ON THE ROAD ENCOURAGES

PEDESTRIANS AND CYCLISTS TO TAKE AN ACTIVE PART IN HELPING BUILD SAFER PLACES IN OUR COMMUNITIES TO BE PHYSICALLY ACTIVE.
