Now come the undersigned who being duly sworn make
affidavit as follows:

1. That on the 15th day of October 1962 pursuant to
Title 45, Chapter 26, Section 2, of the General Laws of Rhode
Island, 1956, in accordance with authority vested in the Town
Council of the Town of Lincoln at a regular meeting
held in the Town Hall the Town Council on that date on
its own motion gave its consideration to the need for a Town
Housing Authority to function in the Town of Lincoln that
on that same date, the said Town Council, by resolution duly
passed, determined that (a) unsanitary or unsafe inhabited
dwelling accommodations existed in the Town of Lincoln and
(b) that there was a lack of safe or sanitary dwelling accommo-
dations in the Town of Lincoln available for the inhabitants
thereof, and, consequently, that there was a need for the
Housing Authority to function in the Town of Lincoln that
pursuant to Title 45, Chapter 26, Section 4, the Honorable
Town Council of the Town of Lincoln duly appointed the
undersigned Commissioners of the Housing Authority of the
Town of Lincoln.


