

ARTICLES OF INCORPORATION
(To Be Filed In Duplicate Original)

The undersigned acting as incorporator(s) of a corporation under Chapter 7-1.1 of the General Laws, 1956, as amended, adopt(s) the following Articles of Incorporation for such corporation:

1. The name of the corporation is Anchor Steam, Inc.

(This is a close corporation pursuant to § 7-1.1-51 of the General Laws, 1956, as amended.) (Strike if inapplicable.)

2. The period of its duration is (if perpetual, so state) perpetual

3. The specific purpose or purposes for which the corporation is organized are:
To conduct a for-profit business rendering tattoo services to the general public. To retain and/or employ tattoo artists for the purpose of tattooing members of the general public. For any other authorized purpose recognized under the General Laws of the State of Rhode Island.

4. The aggregate number of shares which the corporation shall have authority to issue is:




