Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

**ARTICLE I**

The name of the corporation is Holy Communion Anglican Church

**ARTICLE II**

The period of its duration is  Perpetual

**ARTICLE III**

The specific purpose or purposes for which the corporation is organized are:

HOLY COMMUNION ANGLICAN CHURCH IS ORGANIZED EXCLUSIVELY FOR RELIGIOUS, CHARITABLE, AND EDUCATIONAL PURPOSES WITHIN THE MEANING OF SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE, AND IT IS MORE SPECIFICALLY ORGANIZED AS A CHRISTIAN CHURCH ENGAGING IN WORSHIP IN THE ORTHODOX ANGLICAN TRADITION AS PART OF THE ONE HOLY CATHOLIC AND APOSTOLIC CHURCH.

**ARTICLE IV**

Provisions, if any, not inconsistent with the law, which the incorporators elect to set forth in these articles of incorporation for the regulation of the internal affairs of the corporation are:

IN THE EVENT OF THE DISSOLUTION OF THE CORPORATION, THE ASSETS SHALL BE DISTRIBUTED FOR ONE OR MORE EXEMPT RELIGIOUS, CHARITABLE, OR EDUCATIONAL PURPOSES WITHIN THE MEANING OF SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE.
