ARTICLE VII: DISSOLUTION

SECTION 1 — THE CORPORATION MAY ONLY BE DISSOLVED BY A UNANIMOUS VOTE OF THE MEMBERSHIP.

IN THE EVENT OF DISSOLUTION, ASSETS OF THE CORPORATION SHALL BE DISTRIBUTED FOR ONE OR MORE EXEMPT PURPOSES WITHIN THE MEANING OF SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE, OR CORRESPONDING SECTION OF ANY FUTURE FEDERAL TAX CODE, OR SHALL BE DISTRIBUTED TO THE FEDERAL GOVERNMENT, OR TO A STATE OR LOCAL GOVERNMENT, FOR A PUBLIC PURPOSE.

THE RECIPIENT OF THE NET ASSETS SHALL BE DETERMINED BY 2/3 VOTE OF MEMBERSHIP.
