Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is Rhode Island Senate Open

ARTICLE II

The period of its duration is Perpetual

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

THE PURPOSE FOR WHICH THIS CORPORATION IS ORGANIZED IS TO ENGAGE IN ANY SUCH LAWFUL ACT AND/OR ACTIVITY UNDER THE PROVISIONS OF TITLE 7, CHAPTER 6 OF THE GENERAL LAWS OF RHODE ISLAND, ALL BEING WITH A CHARITABLE OBJECTIVE TO ENHANCE THE QUALITY OF LIFE OF RHODE ISLANDERS AND INCLUDING THE MAKING OF DISTRIBUTIONS TO ORGANIZATIONS THAT QUALIFY AS EXEMPT ORGANIZATIONS UNDER SECTION 501(C)(3) OF THE IRS CODE. UPON DISSOLUTION OF THIS ORGANIZATION, ASSETS SHALL BE DISTRIBUTED FOR ONE OR MORE EXEMPT PURPOSES WITHIN THE MEANING OF SECTION 501(C)(3) OF THE IRS CODE OR TO STATE OR LOCAL GOVERNMENT FOR A PUBLIC PURPOSE. NON DISPOSED ASSETS SHALL BE DISTRIBUTED BY A COURT OF COMPETENT JURISDICTION FOR SUCH PURPOSES.
