Dear Attorney Corneau:

The Office of the Attorney General has received your request that this Office partially waive penalty fees for your client's corporation, the Lawrence Sunset Cove Association.

Pursuant to R.I. Gen. Laws §7-1-23 the Attorney General may "compromise" any penalty and permit the payment of a "smaller sum" that what has been assessed. There is, however, no provision for a complete waiver of the fees.


This letter is to inform you that the Attorney General authorizes a reduction of the twenty-eight (28) penalty fees totaling \$700 down to the equivalent of one year's fee, namely \$25.00

It is enacted by the General Assembly as follows:

1 SECTION 1. The time within which LAWRENCE-SUNSET COVE ASSOCIATION,
2 incorporated on September 26, 1968, shall file the reports for the years 1994, 1995, 1996, 1997,
3 1998, 1999, 2000, 2001, 2002, 2003, 2004, 2005, 2006, 2007, 2008, 2009, 2010, 2011, 2012, 2013,
4 2014, 2015, 2016, 2017, 2018, 2019 and 2020, as required under the provisions of Chapter 6 of
5 Title 7 of the General Laws, 1956, is hereby extended to the 31st day of December, A.D., 2020, if
6 said corporation shall file in the office of the secretary of state before December 31, 2020, the
7 reports which it should have filed in the said years and shall pay to the secretary of state the filing
8 fees therefor, having previously thereto paid to the general treasurer for the use of the state such
9 sum as the attorney general shall decide should be paid by said corporation as a compromise for
10 the penalty or penalties for its failure to file such reports then the forfeiture or revocation of the
11 charter of said corporation shall thereupon, to wit, upon the filing of said reports and the payment
12 of said fees, be vacated and said corporation shall thereupon be entitled to all of the privileges,
13 benefits and powers and subject to the same duties and liabilities as though no forfeiture or
14 revocation of its said charter had taken place.

15 SECTION 2. This act shall take effect upon passage.
