The corporation shall have ten (10) days in which to accept or reject said offer.

Any stockholder who shall have offered his stock for sale to the corporation in accordance with the foregoing provisions, any, at any time within twenty (20) days after the rejection of such offer by the corporation, or if within such period the corporation shall neither accept nor reject such offer, then within twenty (20) days after such offer shall have been received by the corporation, sell the stock so offered to the corporation to any other party, but not for a price lower than that at which such stock shall have been previously offered to the corporation, and the corporation may require affidavits from the stockholder and the purchaser of such stock as to the price paid therefor before transferring such stock upon the books of the corporation.

Sixth. Provisions (if any) for the regulation of the internal affairs of the corporation:

Every officer, director, and shareholder of the corporation shall be an individual authorized to practice the profession and shall be employed by the corporation.
