ARTICLE I

The name of the corporation is Northern Lincoln Elementary PTO

ARTICLE II

The period of its duration is Perpetual

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

THE PURPOSE OF THE PTO IS TO ENHANCE AND SUPPORT THE EDUCATIONAL EXPERIENCE OF CHILDREN AT NORTHERN LINCOLN ELEMENTARY SCHOOL, TO DEVELOP A CLOSER CONNECTION BETWEEN SCHOOL AND HOME BY ENCOURAGING PARENT INVOLVEMENT, TO FOSTER RELATIONSHIPS AMONG THE SCHOOL, PARENTS AND STAFF, AND TO IMPROVE THE ENVIRONMENT AT NORTHERN LINCOLN ELEMENTARY SCHOOL THROUGH VOLUNTEER AND FINANCIAL SUPPORT.
