It is enacted by the General Assembly as follows:

1 SECTION 1. The time within which the Providence County Kennel
2 Club, incorporated February 10, 1917 shall file the reports for the
3 years 1974, 1976, 1978, 1980, 1982, 1984, 1985, 1986, 1987, 1988,
4 1989, 1990, 1991, 1992, 1993, and 1994 as required under the provi-
5 sions of section 7-6-14 of the general laws of Rhode Island, 1956, is
6 hereby extended to the 31st day of December, A.D. 1994. If said cor-
7 poration shall file in the office of the secretary of state before
8 December 31, 1994 the reports which it shall have filed in the said
9 years 1974, 1976, 1978, 1980, 1982, 1984, 1985, 1986, 1987, 1988,
10 1989, 1990, 1991, 1992, 1993, and 1994 and shall pay to the secretary
11 of state the filing fees therefor, having previously thereto paid to
12 the general treasurer for the use of the state such sum as the attor-
13 ney general shall decide should be paid by said corporation as a com-
14 promise of the penalty or penalties for its failure to file such
15 reports, then the forfeiture or revocation of the charter of said cor-
16 poration shall thereupon, to wit, upon the filing of said reports and

1 the payment of said fees, be vacated and said corporation shall there-
2 upon be entitled to all of the privileges, benefits and powers and
3 subject to the same duties and liabilities as though no forfeiture or
4 revocation of its said charter had taken place.

5 SECTION 2. This act shall take effect upon passage.
