ARTICLES OF ASSOCIATION.

Know all Men by these Presents, That we Harry Krikorian, Hiram Hovnanian, Hagop Halkasian, Sarkis D. Bogosian, Charles D. Johnson, Krikor Najarian and Stephen B. Jacobian, all of the City and County of Providence in the State of Rhode Island,

all of lawful age, hereby agree to and with each other:

1st. To associate ourselves together for the purpose of constituting a corporation under and by virtue of the powers conferred by Chapter 212 of the General Laws of Rhode Island: 1909.

2nd. Said corporation shall be known by the name of **ARMENIAN EVANGELICAL CHURCH OF PROVIDENCE.**

3rd. Said corporation is constituted for the purpose of promoting the religious, moral and social welfare of Armenian people in Providence, Rhode Island, and vicinity, according to the tenets and faith of the Congregational organization of the State of Rhode Island.

4th. Said corporation shall be located in the City of Providence, County of Providence in the State of Rhode Island.
