Without limiting or y, it is hereby specifically provided that every such corporation shall have orate name unless a period for its duration is limited in its articles of associate;
ing meetings of its members and directors, the mann the number, qualifications, powers, duties and term	ner of electing its officers and directors, the mode of voting by proxy, and of office of its officers and directors, and containing any other provisions, nanagement of the corporation's property and the regulation and government

Said corporation shall be entitled to take, hold, transmit and convey real and personal estate to an amount not exceeding in all one hundred fifty thousand dollars (\$150,000); provided, however, that the foregoing limitation shall not apply to corporations organized for the purposes of fostering, encouraging and assisting the physical location, settlement or resettlement of industrial and manufacturing enterprises within the state, and to whose members no profit shall control. If any corporation subject to the foregoing limitation desires to take and hold property to an amount exceeding one hundred fifty thousand dollars (\$150,000) either originally or by amendment, such privilege shall be granted only by the general assembly on petition thereto
