3. Upon filing of the Annual Reports and the payment of the filing fees, Defendant shall reinstate the charter of the Plaintiff Corporation and consider the same to be in good standing retroactive to the date of the forfeiture of the Plaintiff's charter.

4. Plaintiff waives any right to a hearing de novo pursuant to Sections 7-1.1-89 and 7-1.1-133 of the R.I.G.L., as amended.
