ORIGINAL ARTICLES OF INCORPORATION

The undersigned, acting as incorporator(s) of a corporation under Chapter 7-6 of the General Laws, 1956, as amended, adopt(s) the following Articles of Incorporation for such corporation:

Internal affairs of the organization are regulated by a Board of Directors and Organization By-Laws. Upon the dissolution or final liquidation of the corporation, the Board of Directors shall after paying or making provisions for payment of all liabilities of the corporation, dispose of all assets of the corporation exclusively for the purpose of the corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational, religious, or scientific purposes shall at the time qualify as an exempt organization and is qualified to conduct business in the United States or Territory of the United States or District of Columbia.
