



ARTICLES OF INCORPORATION OF A NONPROFIT CORPORATION

BE IT KNOWN that the undersigned, all of whom are residents of the Commonwealth of Pennsylvania and citizens of the United States, and all of whom are of full age, having associated themselves together for the purpose of organizing the RESOURCES FOR HUMAN DEVELOPMENT, INC.

and being desirous of becoming incorporated in accordance with the provisions of the Act of the General Assembly of the Commonwealth of Pennsylvania known as the "Nonprofit Corporation Law" approved May 5, 1933 as amended, do hereby declare, set forth and certify as follows:

ARTICLE I. The name of the corporation is RESOURCES FOR HUMAN DEVELOPMENT, INC.

which name has been registered with the Department of State of the Commonwealth of Pennsylvania within six months of the date of application for this charter.

ARTICLE II. The location and post office address of the initial registered office of the corporation shall be 18 W. Airy Street Norristown, Pennsylvania 19401.
