ARTICLES OF INCORPORATION

(To Be Filed In Duplicate Original)

The undersigned acting as incorporator(s) of a corporation under Chapter 7-1.1 of the General Laws, 1956, as amended, adopt(s) the following Articles of Incorporation for such corporation:

1. The name of the corporation is RID-ALL EXTERMINATING CORPORATION

(This is a close corporation pursuant to § 7-1.1-51 of the General Laws, 1956, as amended.) (Strike if inapplicable.)

2. The period of its duration is (if perpetual, so state) Perpetual

3. The specific purpose or purposes for which the corporation is organized are:

To engage in the business of pest control, fumigation, pest extermination and sterilization, and termite control, including the use of such chemicals as the corporation may be licensed and permitted to use, the preparation of reports and the making of inspections as required, and the servicing of properties in the matter of extermination and fumigation in all phases of the work of pest control in whatever respect the corporation may be licensed to do.

4. The aggregate number of shares which the corporation shall have authority to issue is:

The corporation shall have a lien and right of preemption upon its outstanding stock to be enforced in accordance with the bylaws of said corporation.




