(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is Little Compton Food Bank

ARTICLE II

The period of its duration is Perpetual

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

THE LITTLE COMPTON FOOD BANK IS A WEEKLY FOOD DISTRIBUTION PANTRY. THE LC FOOD BANK IS AVAILABLE TO LITTLE COMPTON AND TIVERTON RESIDENTS WHO HAVE DIFFICULTLY PURCHASING FOOD FOR THEMSELVES AND THEIR FAMILIES.
