ARTICLES OF AMENDMENT TO
ARTICLES OF INCORPORATION
(To Be Filed In Duplicate Original)

Pursuant to the provisions of Section 7-6-40 of the General Laws, 1956, as amended, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is riva (rhode island vegetarian action)
2. The following amendment to the Articles of Incorporation was adopted by the corporation:

[Insert Amendment]

- 1) The organization shall be called riva, rhode island
vegan awareness instead of rhode island vegetarian action.
- 2) The word "vegan" shall be substituted for the word
vegetarian in Article 3, section (a).
- 3) Article 3, section (b) shall be re-written to read: "to promote
the values of veganism including but not limited to compassion
for other species, ecological harmony, human health and
sustainability"
- 4) Article 3 section (c) shall be omitted entirely and shall now read
"to educate others regarding the scientific, ethical, environmental
and other aspects of veganism."
- 5) Article 3 section (d) shall be changed to: "utilize all
lawful means, (publications, tracts, media, meetings,
lectures, conferences, discussions, seminars, and other
means of mass communication,) to promulgate the views
and aims of veganism; and"
- 6) Article 3 section (e) shall now read: "to coordinate
and organize the vegan movement in Rhode Island,
and to cooperate with other organizations and
individuals with substantially similar interests."
